

Dear Shanna,

Our heartfelt thanks to you and the Peoples Bank Grant Committee for the donation! What a nice surprise to open an envelope with a donation in it rather than the daily pile of envelopes with bills inside. It has been a pleasure to work with Everett Lamers over the last year as one of our recent additions on the Columbia Valley Housing Association Board of Directors.

Our non-profit organization provides financial education, homeownership counseling and down payment assistance to low-income, very low-income, and disabled families who are trying to buy their first homes. Often our clients are single mothers with children, families raising disabled children, or hard-working agricultural families. They all work very hard but have serious difficulties in saving any extra money each month for the down payment and closing costs required to buy a home. With rent prices skyrocketing throughout our state, participants in our low-income programs often end up paying \$950-\$1500 for a mortgage on a modest home rather than \$2200 on rent.

Our affordable homeownership program is one of the very few across our state and nation that actually lift families up and out of poverty for good by helping them build wealth back slowly through homeownership. Emergency programs often end up churning our most vulnerable families from program to program without ever improving their financial situation for the long term. We work on a very lean annual budget to accomplish our important mission and really appreciate every single dollar that is donated to help our work.

Thank you for all the work you do at Peoples Bank to support great community projects and organizations like ours. You've been great partners to Columbia Valley Housing Association for many years now.

On behalf of the Board of Directors and the staff at the Boys & Girls Clubs of Whatcom County, I would like to thank you for your very generous gift which was received today.

We will designate your donation to phase two of our Building Blocks for the Future capital campaign – the purchase of the property located at 2320 Yew Street, Bellingham. I so appreciate your willingness to commit at such a significant level to help us launch this phase of the campaign successfully.

In December 2019, Kids' World announced it would be closing its four locations, jeopardizing 532 affordable childcare places for kids from infant to age 12. With an already critical shortage of childcare in Whatcom County, we knew we needed to step up and serve our community in a new way. On March 1, 2020, we acquired all four early learning centers.

We have been operating the centers for two years and the continued sustainability of this expanded service to families, hinges on the strategic purchase of the leased locations as quickly as possible. Thanks to our generous community, we completed phase one of the capital campaign to purchase the Ferndale facility in October, 2021.

We are working toward completing the purchase of the Yew Street property by May 31, 2022 and your gift helps us reach that goal, thank you.

We appreciate you partnering with us and being part of the solution to the childcare crisis in our community.
